In 2023, ART 180 conducted 31 programs in creative expression for 416 youth aged 8-18 led by more than 35 artists. We engaged with 16 partners who work with a variety of young people who, restricted by systemic barriers, do not always have access to quality afterschool arts programs. ART 180 delivered more than 600 hours of programming through multi-week afterschool sessions in our community based programs in collaboration with schools and other youth-serving organizations, as well as through Atlas, our teen art center and gallery. Teen mental health and community engagement were major themes in our 2023 programs, and ART 180 became a restorative space for our community.
